

# **AUTHOR GUIDELINES for *Bat Research News***

## **General Guidelines**

Please follow **CSE style**.

Manuscripts should be in 12 point Times New Roman (fonts) and double spaced.

Please include full names of authors (given and surnames requested, middle initials optional), affiliations and addresses, and e-mail address for corresponding author.

Follow this format for title and authors:

**The Seminole Bat (*Lasiurus seminolus*) and Virginia Big-eared Bat (*Corynorhinus townsendii virginianus*) in Pennsylvania**

Full-length articles should use standard subheadings (Introduction, Methods, Results, and Discussion), whenever possible, and these should be centered and in bold. Subheadings generally are not used for notes (manuscripts less than 6–8 pages in length).

In addition to full-length articles and technical notes, *BRN* also publishes Letters to the Editor. Unlike technical articles, letters are not peer-reviewed, but they are edited for grammar, style, and clarity. Letters provide an outlet for opinions, speculations, anecdotes, and other interesting observations that, by themselves, may not be sufficient or appropriate for a technical article. Letters are typically 1–3 pages in length.

**Photos and illustrations** need to be in **.jpg format**.

The **final manuscript** should be sent in **.rtf format** to: Dr. Allen Kurta ([akurta@emich.edu](mailto:akurta@emich.edu)).

## Format for References

List references in alphabetical order by first author under “**Literature Cited**” at end of manuscript.

Use an **n-dash for all ranges, including pagination**.

References with more than six authors should begin with name of the first author only, followed by et al.
